5. FIRE-FIGHTING MEASURES

Suitable extinguishing media Water spray, fog, CO₂, dry chemical, or alcohol resistant foam.

6. ACCIDENTAL RELEASE MEASURES

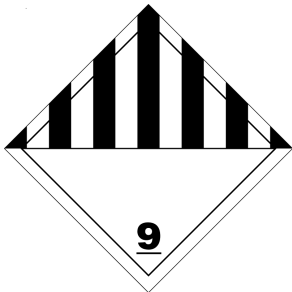
