#### 5. FIRE-FIGHTING MEASURES

**Suitable extinguishing media** Water spray, fog, CO<sub>2</sub>, dry chemical, or alcohol resistant foam.

**Unsuitable extinguishing media** Do not use a solid water stream as it may scatter and spread fire.
