Special protective equipment and precautions for firefighters

Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. 6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up

Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps. Stop the flow of material, if this is without risk.
