### 5. FIRE-FIGHTING MEASURES

### 7. HANDLING AND STORAGE

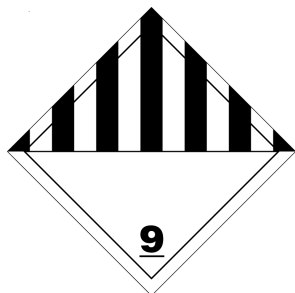

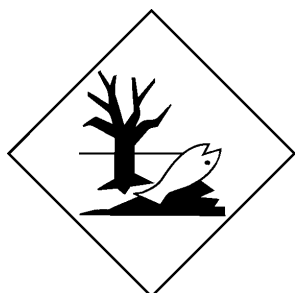
