4. FIRST-AID MEASURES

Inhalation

5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

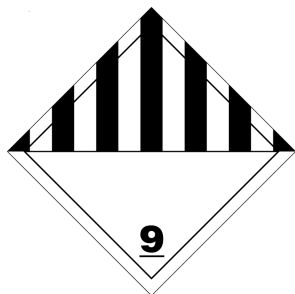

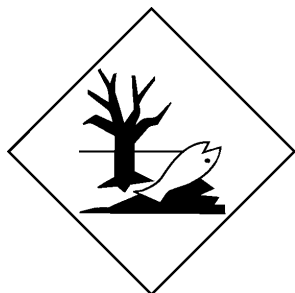
