#### 4. FIRST-AID MEASURES

#### Methods and materials for containment and cleaning up

Collect and dispose of spillage as indicated in section 13 of the SDS.

Absorb with inert absorbent such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps. Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible.
